 - c. approve plans and specifications and authorize advertisement for bids for construction of additional projects; and
 - d. elevated storage tank waiver.

 - c. Ventana Lakes East Drill Site;
 - d. Ventana Lakes East Park;
 - e. Porter Ranch Detention Pond Amenity project; and
 - f. lighting of park land.

 13. Adopt Resolution Casting Ballot for the Election of a Person to the Board of Directors of the Harris Central Appraisal District.
